- No vendor will be allowed to set up unless payment has been received.
- **We reserve the right to reject or accept any application.**
- We ask all vendors to send a color photograph of the product/services being promoted or a photo of the booth itself. The festival committee will screen all applications using these photographs as reference. The committee reserves the right to select exhibitors through this process. All decisions regarding selection of the exhibitors are the sole discretion of the committee and are final. If an applicant should be denied participation, a full refund of booth fees will be mailed to the applicant. (No yard sale/flea market type items allowed.)

**Business Vendor Rules**

1. All booth spaces are 10' x 10'. A photo of your display must be included with your application.
2. No one vendor will have exclusive rights to the show.
3. All set-ups must be professional in appearance.
4. Each exhibitor is to provide all materials needed for their own booth. All tents must be a standard 10' x 10'.
5. An exhibitor may purchase more than one booth if needed.
6. Please bring and display a sign with your business or group's name on it.
7. All appropriate forms must be completed, signed and returned with payment by October 12, 2010.
8. The event is on Saturday, November 6, 2010 from 10:00 a.m. – 5:00 p.m. Set-up time is Saturday morning from 6:30 – 9:30 a.m. **All vehicles must be out of the festival area by 9:00 a.m.**
9. No vehicle will be allowed on festival site for dismantling until 5:00 p.m. Do not dismantle or remove any displays during festival hours. Please have your materials packed before getting your vehicle. If a booth is dismantled before 5:00 p.m., the vendor will risk not being allowed to participate again.
10. Each vendor is responsible for their own cleanup or risk not being allowed to return. Trash should be hauled away by each vendor.
11. All vendors should have an accurate NC Tax ID Number. For more information call NC Department of Revenue at 1-877-252-3052 (sales & use tax) or go to their website: <http://www.dor.state.nc.us>
12. All vendors are required to complete the City of Statesville privilege license application and submit it along with Pumpkin Fest application. (See attached)
13. This festival is family-oriented for spectators of all ages; therefore, displays must be in keeping with this atmosphere. Festival staff shall have the sole right to require removal of work or materials which violates any of the festival rules. Continued violation will result in removal from the festival and/or ineligibility for future festivals.
14. **NO REFUNDS AFTER OCTOBER 15, 2010 FOR ANY REASON:** Including late arrival, placement or inclement weather.
15. The Crossroads Pumpkin Fest reserves the right to deny any application.
